**Merger by absorption of Protectas Electronic Security Sàrl into Protectas Technology SA**

Dear customers, partners and suppliers,

We hereby bring to your notice that the managing directors of Protectas Electronic Security Sàrl and the Board of Directors of Protectas Technology SA have entered into a merger agreement, by which Protectas Technology SA acquires its sister company Protectas Electronic Security Sàrl. **The merger was published in the SOGC on 26 June 2024. Therefore, we kindly request you to update the changes in your systems immediately.**

This merger is part of a strategy to strengthen our position in the electronic security market at the national level. For several years within the Protectas group (part of the Swedish Securitas AB group), we have been actively working to consolidate our expertise in this strategic sector, as well as the trust you place in us. The merger means that Protectas Technology SA will take over all the rights and obligations of Protectas Electronic Security Sàrl. All contracts of this company will be automatically transferred to Protectas Technology SA.
